

## Personal Data Protection

For the use of the MyAirBridge.com application, it is necessary to process some of your personal data. This data is used especially for sending files, improving the MAB service, and ensuring the security of the application. We never share your personal data with third parties. Before using the MAB application and the expanded version of it - MAB Profile - you are required to agree with the Personal Data Protection Terms and Conditions, which are stated in this document. These terms and conditions are also an integral part of The Use of MyAirBridge.com App Terms and Conditions.

If you are a MAB user with free registration or a free profile, we process this information: the registration email address, the data sender's email address and the data recipient's email address/es.

If you are sending data via email (with email notification), we also process the filled-in subject of the email message, any accompanying text, and also the full list of files sent in the data transfer.

If you are a MAB user with a paid profile, in addition to the above-mentioned information we also process your name and surname, address, city, country, ZIP, email for communication regarding payments, the VAT registration number, and the name of your company.

### Purpose of Processing Personal Data

We always try to request the smallest amount of personal data as possible from our users. In order to use the MAB application without registration or with the free profile, it is necessary to enter the e-mail of the recipient and the sender, upload the file(s) and, if required, add a personal message which would be displayed to the recipient in the e-mail notification. In order to send data via a shared link, the only necessary step is to upload the file(s).

We further process your personal data for the conclusion and administration of the MyAirBridge user contract. In such a case, your personal data is processed only in the scope necessary to conclude and perform the contract.

Personal data of free profile users are stored for 12 months, after that, the records are anonymous and used only for statistics. Paid profile user data are stored for the duration of the paid profile. After the paid profile is terminated, the data are stored for 12 months, and after that, the records are anonymous and used only for statistics.

In order to make the app as user friendly as possible, MAB installs cookie files essential for the smooth operation of the application.

Sent files are deleted 3 days after the transfer (unless the paid profile settings state otherwise)

if the size of the sent data does not exceed 2 GB. If the size of the sent data exceeds 2 GB, it is deleted after 2 days (unless the paid profile settings state otherwise). MyAirBridge does not support searching in the files and does not monitor the files in any way. However, it may generate file previews automatically, which are shown to the data sender and the data recipient.

### **Personal Data Protection For Users With MAB Profile**

If you use one of the MAB profiles, MyAirBridge must also process further personal data, so that it is easier to create your profile and generate invoices i.e. the data which you enter via Nuvei or Stripe. MyAirBridge may furthermore use the personal data to the necessary extent during an investigation of any illegal activity, application of the NTD policy or, if necessary, for the purpose of protection against legal actions due to your use of the MAB profile. MyAirBridge processes the full name of the user, e-mail addresses, city, country, billing information, password, files (and their types) and the content of accompanying messages sent with the transfers. MyAirBridge does not store any other personal data and does not store or publish personal data and information about the file contents. For facilitating the work with the MAB profile (language settings or login), we install sessions and settings into cookies, but always in only the absolutely essential amount to ensure the smooth run of the application.

### **Our Guarantee**

MyAirBridge will not sell or hand over your personal data to any third parties. The collected personal data will be used solely in order to ensure the smooth run of the application and website, for the application of the NTD policy, for the cooperation with the authorities active in the criminal proceedings, or in case of misuse of the service. The data made anonymous shall be utilised solely for statistical purposes.

In order to secure the proper functionality of the app and to be able to provide quality service to you, some third parties have access to your personal data. These third parties, however, are only the law office, the accounting office and a limited number of personnel working for companies that provide services to us. To secure your personal data we do have proper contracts on processing personal data with all such companies.

### **Global Data Security**

Individual files, thus also the personal data, may be transferred via servers in the United States or EU. By using the MAB application you agree with MyAirBridge transferring the data and personal data via servers that may be outside the EU when necessary.

## Use of the Application by Users Under 18 Years of Age

The MAB application can be used by individuals that are 16 years of age, or younger, but only with the consent of the parents or legal representatives.

## Personal Data Protection Terms & Conditions Updates

Personal data protection terms & conditions can be updated. If that happens, the system will ask you to agree with the new terms and conditions, and therefore to update your consent regarding personal data processing.

You have the right to ask for data removal, the right to ask for correction of inaccurate or incomplete personal data, the right to restrict data processing and the right to object to profiling, automated decision-making and data transferring. You can claim these rights by contacting our company using the contact details listed below.

You can also file a complaint with the Data Protection Authority.
